



### East County Stimulus Contest Rules

#### **HOW TO ENTER**

**NO PURCHASE NECESSARY.** To enter, complete the online entry form at [www.trylocalfirst.org](http://www.trylocalfirst.org) or print out a form and follow instructions on said form. To be eligible, entries must be completed and received on or by the closing date. Incomplete entries will be disqualified. All entries shall become the property of contest organizers. Contest organizers are not responsible for lost, misdirected or delayed entries. Entries received by telephone, fax, courier or email will not be accepted.

#### **CONTEST RULES**

1. The Try Local First contest is open to Oregon residents living within a 10 mile radius of the cities of Troutdale, Wood Village, Fairview and Gresham, who are over the age of 18 as of October 1st, 2010. Identification must be produced on request.
2. Contest starts 9:00 am June 15, 2010 and concludes 5:00 pm July 25, 2010.
3. Contest participants may complete the online registration form at [www.trylocalfirst.org](http://www.trylocalfirst.org), including their name, phone number, email address and home zip code where indicated. Contest participant may also print out a form and complete per instructions on said form.
4. By participating in the contest, entrant agrees to accept email announcements and coupons from contest organizers.
5. One entry will be selected for each of the 3 packages from all entries received by the contest end date.
6. Winner need not be present to win.
7. Winner will be notified by email after the contest end date.
8. Winner will receive one of the giveaway packages that can be used at any of the businesses throughout Fairview, Troutdale, Wood Village and Gresham. Any one person or household may not win more than one package.
9. No change will be given.



10. The prize is not redeemable in cash and must be accepted as awarded.

In the event the contest winner is not able to be reached within three (3) attempts at the phone number give on the entry or is not able to be reached by e-mail (three attempts & given 24 hours to respond each time) winner will forfeit the prize and it will remain the property of contest organizers.
