



Try Local First Holiday Giveaway Contest Rules

HOW TO ENTER

NO PURCHASE NECESSARY. To enter, complete the online entry form at www.trylocalfirst.org. To be eligible, entries must be completed and received on or by the closing date. Incomplete entries will be disqualified. All entries shall become the property of contest organizers. Contest organizers are not responsible for lost, misdirected or delayed entries. Entries received by telephone, fax, courier or email will not be accepted.

CONTEST RULES

1. The Try Local First contest is open to Oregon residents living within a 10 mile radius of the cities of Troutdale, Wood Village, Fairview and Gresham, who are over the age of 18 as of October 28th, 2011. Identification must be produced on request.
2. Contest starts 9:00 am October 28, 2011 and concludes 5:00 pm November 27, 2011.
3. Contest participants may complete the online registration form at www.trylocalfirst.org, including their name, phone number, email address and home zip code where indicated.
4. By participating in the contest, entrant agrees to accept email announcements and coupons from contest organizers.
5. One entry will be selected from all entries received by the contest end date.
6. Winner need not be present to win.
7. Winner will be notified by email after the contest end date.
8. Winner will receive \$500 in cash and \$500 in merchandise & gift certificates from local small businesses.
9. No change will be given.
10. The merchandise prizes and/or gift certificates are not redeemable in cash and must be accepted as awarded.



11. In the event the contest winner is not able to be reached by e-mail (three attempts & given 24 hours to respond each time) winner will forfeit the prize and it will remain the property of contest organizers.
12. Decisions of the contest judges are final - no substitutions will be available.
13. By claiming the prize, the winner authorizes the use, without additional compensation of his or her name and/or likeness and/or voice/photograph and municipality of residence for promotion and/or advertising purposes in any manner and in any medium (including without limitation, radio broadcasts, newspapers and other publications and in television or film releases, slides, videotape, distribution over the internet and picture data storage) which contest organizers may deem appropriate.
